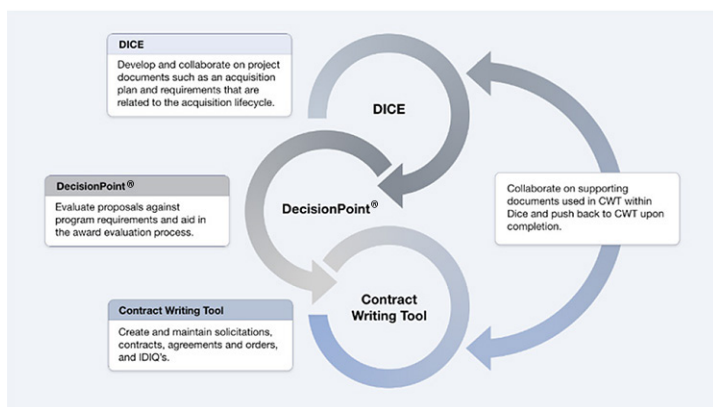

- DICE** (Document Integrity, Collaboration, and Evaluation) – DICE is a secure web-based real-time document collaboration and workflow tool for the development and evaluation of Rich Text and Form documents to meet the needs of a dispersed workforce. DICE offers extensions to integrate with AI solutions that can assist users in the creation of document content. Documents created in DICE can be exported to DecisionPoint® and/or to the Contract Writing Tool.

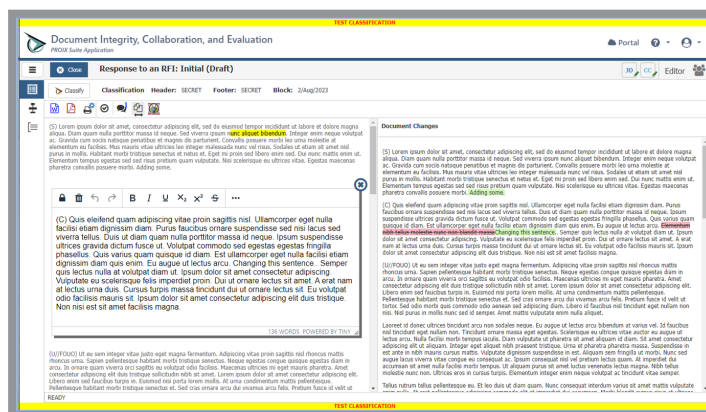
Real-Time Document Collaboration

DICE (Document Integrity, Collaboration, and Evaluation) is a secure, web-based real-time document collaboration and workflow tool for the development and evaluation of Rich Text, Slide Deck and Form documents to meet the needs of a disperse workforce. The document editors and workflow process can be extended and customized through settings and custom plugins to meet the needs of each customer.



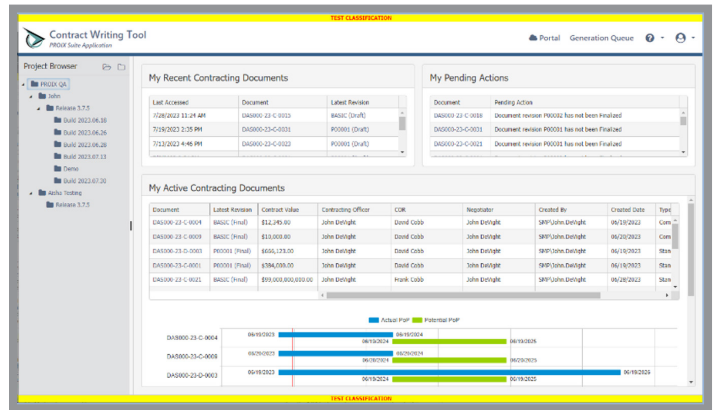
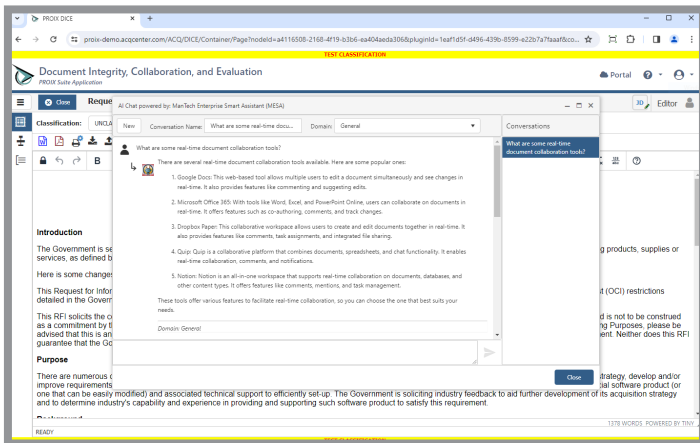
Integration with **DecisionPoint®**, ManTech’s secure web-based source selection and collaboration tool. Templates can be created in and exported from DICE to be used in DecisionPoint®.

Contract Writing Tool – A secure web-based application for assisting Contracting Officers (COs) and their representatives with creating and managing acquisition documentation from solicitation, award, and period of performance to close-out.



- Allows up to 10 reviewers and up to 5 editors to collaborate on a document simultaneously and see the changes in real-time.
- Ensures the integrity of each document by tracking every change that was made, who made the change and when the change was made to provide accountability and traceability in the development of a document.
- Full-featured rich text editor and slide deck editor allows for the development of Rich Text documents and Slide Decks with support for fonts, bullet and numbered lists, tables, charts, and portion marks.

- A form template editor with over 20 different fields allows users to create forms that can be selected for the collaboration of a form document, including DecisionPoint® templates.
- MESA integration using an extension to assist users in the creation of document content.



Supporting applications include the Content Manager, Reference Library, and Vendor Manager.

- Content Manager: Create and manage the content, rules and fill-in values for clauses and prescriptions from multiple regulations as well as page 2 statements for the automated creation of the Block 14 Continuation content of a contract modification or solicitation amendment.
- Reference Library: Used by CWT application users to lookup clauses and their prescriptions.
- Vendor Manager: Manage information about vendors and a web service that can be used by a customer's existing vendor management system as alternative means to providing the CWT application with the vendor information.

Source Selection Management

DecisionPoint®, used in 950+ government agency procurements, is a secure, web-based collaboration tool for reducing protest risk and increasing award schedule efficiency for government agency contract teams. DecisionPoint® helps to enforce the evaluation team's source selection process. Evaluator strengths, weaknesses ratings and risks clearly link to RFP evaluation criteria.

DecisionPoint® is designed to support federal agency program managers and contracting officers that supervise evaluation teams during the source selection process to:

- Maximize online collaboration and increase evaluation efficiency.
- Focus efforts on the quality and substance of the evaluation, not administration, process and logistics.

The Contract Writing Tool (CWT) supports the creation and management of acquisition contracting documents for solicitations, contracts, agreements, and orders and the associated amendments and modifications to these documents.
